Regina Vogler – “I’m interested in Item 14 on page 7 regarding expanding the scope of volunteer paraprofessionals to include transportation. This is a great idea. I read the article in the Asbury Park Press with interest. A minimum is a second set of adult eyes on the bus and at the maximum it gives students someone to go to should an event occur or a situation arise. My concern is on a couple of points. One is the newspaper stated the volunteers would pay for their own security screening. I have no idea what that costs but if I were in a position to be able to volunteer my time, just the fact that I would have to pay to volunteer might offset certain parents. I don’t know if you have funds available to help parents become volunteer paraprofessionals or if the Township has a committee or if there is a liaison there where you can tap funds to help these moms and dads become

chaperones. My second concern is that I've worked with many volunteers in many situations and will there be any type of training or guidelines given to these volunteer chaperones. I've seen parents volunteer to ride busses and are totally ineffective if a situation breaks out right next to them. They don't know how to handle a sick child, a fight, what is appropriate, what is not appropriate. So as this program gets off the ground, you may want to keep that in mind that even though they are volunteers, they should be responsible to follow a certain set of guidelines and to encourage that, I think it would be nice if the District could help to offset the fees for the security screening. Thank you."
