Mr. William T. Andersen, Assistant Superintendent, discussed the district test results for NJASK, GEPA and HSPA (see attached).

Test Scores

Mr. Luick – “Thank you Mr. Andersen. Just a few comments regarding the test scores. One, we know that we have to focus at the Middle and the High School levels. I think he noted that specifically. Secondly, with respect to the programs that are in place, we have identified at least two programs that we know work in this school district. We are going to be looking to expand those in the future to work to see if we can move it ahead throughout the grades, as he mentioned, because we are now going to be testing in grades 5, 6 and 7 as well. In essence, within the next two years we will be testing in virtually all but three of the grades within the public school system. So we know we’re going to have to work.”

Mr. Inzelbuch – “Through the Chair. I do want to report some good news which goes along with Mr. Andersen’s hard work and that of his staff. If you recall, the STRIVE program which we brought back into district and some people had some questions as to the place for these children in the district. The STRIVE students, their mean score and Mr. Andersen could say this in English if I’m not getting it right, the mean score for STRIVE was 185 for the math on the

HSPA and 179 for language arts. The STRIVE students exceeded all other special education placements in the high school this past year.”

Mr. Luick – “The teachers we select and I know Mr. Andersen will be talking more about the inservicing that we’ve been working on, but there is a commitment on the part of our teachers. This year we’ve noticed a real commitment to excel at what they are doing. They have been attending workshops that we offer. They are attentive to new innovations in the field. We’ve brought in professionals from the outside. They spoke with Fred Karick. He’s been in this district a few times working with our personnel and it seems to be having an effect and actually, on the part of the teachers, I made this comment a couple of weeks ago or maybe a month ago. Where the teachers feel once the results came back, we are turning the corner. Let’s keep moving ahead. That seems to be the motivating force on the part of our staff and they are doing a great job.”
